Since 1985, Pace has been a leading advocate, providing programs that help girls and young women thrive across more than 23 communities in Florida, Georgia, and South Carolina. Pace envisions a world where all girls and young women are safe, have economic security and an opportunity to use their voice in shaping their future. Pace has served approximately 3,000+ girls each year, with a total of 40,000+ since 1985.

As a reminder, we will be collecting for the Pace Center for Girls in Orlando, during the annual institute in September 2025. Requested items are needed: underwear (size S-XXL), soap, toothbrushes, toothpaste, deodorant, hair ties, shampoo, and conditioner (for different types of hair).

We also have a wish list for our boutique, the Pace boutique is a special space where our girls "shop" using points they've earned throughout the school year through their hard work and achievements. To motivate and reward their efforts, we strive to keep the boutique stocked with items that excite and inspire them. The girls themselves have provided input on what they'd love to see, many of which are things they desire but can't easily obtain due to their families' limited income. To ensure we can keep offering new and exciting options, we've put together an Amazon list with items suggested by the girls. Finding the Balance: Leadership and Management Principles

In the Criminal Justice Profession, effective leadership requires a balance between inspiring people and managing processes. When we focus too much on one, we risk creating an organization that either lacks direction or fails to connect with its people. Leadership motivates, while management ensures things run smoothly, but without both, neither will thrive.



Have you ever worked for someone who could inspire you but couldn't back it up with action? Leaders can motivate, but without solid management systems, their efforts can fall flat. On the other hand, focusing only on managing processes may streamline operations but can leave employees feeling undervalued. Without connection, morale suffers.

"He can talk the talk – but can he walk the walk?"

True leadership in our field requires both inspiration and responsibility. As my uncle and former Colonel Andy Hart often said, "If you take care of the small stuff, the big stuff will take care of itself." By focusing on the details, like progressive discipline, communication, and daily tasks, we lay the foundation for bigger successes. He also said, "Always take care of your people, because your people are who take care of you," highlighting the importance of creating a culture where your team feels valued and supported.

The challenge for all of us, regardless of rank, is to apply both *leadership* and *management*. Whether you're a Sheriff or Deputy, Warden or Officer, Manager or Staff Assistant, balancing these principles is crucial to building a strong, effective team.

I've had my struggles finding that balance, but I've been blessed to work with leaders who showed me the way and held me accountable when I needed correction. As a result, I've been part of some incredible teams. I would not be where I am today if the mentors before me had not applied both the principles of leadership and management equally in my development as a supervisor, manager, and leader.


Whether I am elected to FCCD State Board or not, I wanted you to get a snapshot of what drives me as a leader.






EMPLOYEE APPRECIATION LUNCHEON


Their involvement in the Autism Walk is a testament to FCCD's broader vision—advancing positive change not only within the criminal justice system, but throughout the communities it serves.




SUPPORTING SPECIAL OLYMPICS




VALENTINE'S BASKET


