He did share that there is a decrease in membership during this guarter therefore all efforts are needed State-wide to help FCCD sustain its membership.

President Report.....President Shelley Liddle

- President Liddle welcomed everyone to the 1st Quarterly Board meeting via zoom conferencing.
- President Liddle discussed the Institute Budget which is in good standing at this time.
- President Liddle introduced Chris from (NPP) National Purchasing Partners which is featured on the FCCD Website. Chris discussed the benefits and discounts that are available to individuals and departments.
- President Liddle shared with the membership due to the challenges relating to COVID that the
  Executive Board Members that there would not be an in person quarterly board meeting in
  February 2021. It is in the best of FCCD that due to changing in United States Presidents Office
  and unknown changes to COVID restrictions that the 2<sup>nd</sup> Quarterly Board meeting be held via
  zoom. The 2<sup>nd</sup> Quarterly Board Meeting will be held on February 18,2020 at 6:30 pm via zoom.
- President Liddle shared with the membership that the 3<sup>rd</sup> Quarterly Board Meeting will be held in person at The Shores in Daytona Beach, Florida from May 21 – 22, 2021.
- President Liddle shared the 4<sup>th</sup> Quarterly Board Meeting and the 91<sup>st</sup> FCCD Training Institute will be held in person at The Rosen Hotel in Orlando, Florida from August 23-26, 2021. The conference colors and theme will remain the same.
- President Liddle discussed the challenges facing FCCD membership state-wide, Last year the membership was at 2,566, April 2020 it was 2,662 and currently it has dropped to 2,442.
- President announced in effort to address the membership decline the Executive Board Members discussed and proposed cash prizes to those who are assisting in increasing the membership. The proposal would permit the when a person signs up three new members their name will be submitted in for the \$500.00 cash drawing to be conducted quarterly, The expectation is that a person names can be submitted for as many sets of 3 new members they get to join FCCD. The goal is to increase the state-wide membership to 3,000. A flyer with the specific details of this membership drive will be shared with everyone via the FCCD website this week,
- Past State President Mike Page recommended that we showcase the membership drive flyer on the main page of the FCCD Website.
- Executive Director Gina Giacomo encouraged that everyone participate as membership is the lifeline of FCCD.
- President Liddle provide an update on the Liability Insurance in which under the new insurance carrier MILO there was an annual cost savings of \$2,000.00. The MILO Liability Insurance now covers the Executive Board Members as well as the Chapter President state-wide.
- President Liddle announced that she would keep the current Committee Chairs for this upcoming year with the expectation that she will need to fill some vacancies.
- President Liddle had the Chapter Presidents and Committee Chairs give a brief report to the membership.

• President Elect Starling shared with the membership that the that 2022 FCCD Training Institute is set for Panama City, Florida as well as thanked all the attendees and members for their support of FCCD in these challenging times.
