Sponsored by Advanced Recovery Systems since 2016, Real Talk highlights the realities and differences between mental and physical effects of alcohol on the brain, as well as emerging trends among youth regarding experimentation with different substances. The Presenters are Michaela McLean – Current Miss Florida; Alexandria DeRoos – Current Miss Gainesville Outstanding Teen and Lindsay Betts – Advanced Recovery Systems.
- Hundred X fundraiser was announced. Possibility is for the Organization to raise approximately \$15,000. Every person who completes 75 qualifying surveys raises \$150 for the organization. FCCD will provide \$25 Amazon gift card to the first 50 who complete all 75 surveys. Opportunity was provided for set up of all complete a few surveys.
